CONDITIONS OF ENROLMENT

ENROLMENT AT HEATHERTON CHRISTIAN COLLEGE IS SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

1. That you will agree to allow the child to share fully in the life and programme of the college.
2. That you will support the aims of the college and order the child's life and home so that the child will be given every opportunity to grow up in Christ.
3. That you will undertake to provide the child with the correct uniform approved by the College, and ensure that the child is always sent neatly and modestly dressed in the required uniform.
4. That you accept the right of the College to employ such discipline as it deems wise and expedient for the child and agree to uphold in every way possible the College's authority and right to administer appropriate discipline in accordance with the policies of the College.
5. That you will pay all fees in advance before the first day of each year or enter into a payment plan set up as a direct debit arrangement with the school for settlement of all fees during the year.

7. That you will pay interest (at the prevailing rate plus two percent) on any amounts remaining unpaid at the end of the school year, and any collection costs, as applicable. You shall pay Heatherton Christian College for all costs incurred by Heatherton Christian College (including costs for which Heatherton Christian College may be contingently liable) in any attempt to collect any monies owed by you to Heatherton Christian College under this Agreement including debt collection agent costs, repossession costs, location search costs, process server costs and solicitor costs on a solicitor/client basis.
8. That you will give at least one term's notice of termination of enrolment in writing to the Principal and failure to do so may render you liable for one term's fees.
9. That the college may suspend or terminate enrolment at its discretion for failure to comply with these conditions or other serious breaches of the College's rules and regulations.
10. That you will provide permission to Heatherton Christian College to make available personal information to Commonwealth and State government agencies.
11. That you will provide Heatherton Christian College with documentation from a suitably qualified person outlining the child's competency in English language skills.
12. That you will advise the College promptly of any change in address or contact details.
13. That you will ensure that the child adheres to the Heatherton Christian College attendance policy (enclosed). Specifically for International Students, the student must attend school at least 80% of the time, in order to comply with visa requirements.
14. That you have carefully read and signed the Heatherton Christian College International Student's Policies and Procedures Handbook, FFPOS Accommodation Policy, Home Stay Policy, Counselling and Support Services, Student Grievance Policy, and Confidential Medical Form.
